CUSTOMER'S TERMS & CONDITIONS FOR THE TYREPLUS INSTANT CASH REBATE PROMOTION ("PROMOTION")

- 3.3.2. the purchase must be made from participating TYREPLUS dealers ("**Dealers**"); You can find out the Dealers by using the dealer locator in TYREPLUS's website, as follows <u>https://tyreplus.com.my/dealers</u>.
- 3.3.3. the products must be purchased within the Promotion Period as indicated in the proof of purchase.

4. <u>How to Participate.</u>

- 4.1. To qualify for the Promotion, Customers must, in a <u>single invoice or receipt</u>, purchase a minimum of: 4.1.1. four (4) units of the Eligible Products with a tyre size of 17" and below; OR
 - 4.1.2. two (2) units of the Eligible Products with a tyre size of 18" and above.
- 4.2. Upon confirmation of purchase, Dealers will provide the instant cash rebate to Customers in accordance with and subject to Clause 5 of these Terms and Conditions.
- 4.3. The Promotion may not be used together with any other promotions, contests, offers or discounts, unless otherwise stated.

5. Instant Cash Rebate.

- 5.1. Instant cash rebate is provided strictly on a first-come, first-served basis, and only while stocks of the Eligible Product last.
- 5.2. The instant cash rebate values are determined as follows:

6. <u>Claiming the Instant Cash Rebate.</u>

- 6.1. Instant cash rebate is to be given at the point of purchase from the applicable TYREPLUS dealers. For the avoidance of doubt, you cannot make purchases of Eligible Products from one Dealer and claim the instant cash rebate from another Dealer.
- 6.2. Each Dealer has been allocated a fixed quantity of the Eligible Product eligible for the instant cash rebate Promotion. You may check with the Dealer if any Eligible Products are still available for instant cash rebate Promotion.
- 6.3. For the avoidance of doubt, the instant cash rebate is available only while stocks of the Eligible Product last and MICHELIN will not and is not liable for replenishing the Eligible Products to the Dealers for the purposes of the Promotion.
- 7. Taxes, etc. Taxes and other levies imposed by any relevant applicable government or tax authority, as well as other costs including insurance and incidental costs, that may be levied on or incurred in relation to the instant cash rebate shall be fully borne by the participant.
- 8. - **11.** No waiver. MICHELIN's failure to enforce any provision of these Terms and Conditions shall not constitute a waiver of that or of any other provision.
- **12.** Modification of these Terms and Conditions, etc. MICHELIN may unilaterally modify these Terms and Conditions and/or unilaterally withdraw or terminate the Promotion at any time whatsoever without any liability towards anyone whatsoever.
- **13.** All information is correct at the time of publishing. In the event of any inaccuracy or any discrepancy between the print and online versions, the online version shall prevail over the print version.
- 14. Severability. Each of the provisions of these Terms and Conditions shall apply to the maximum extent permitted by applicable law. If a court holds any provision of these Terms and Conditions to be illegal, invalid or unenforceable, the remainder of these Terms and Conditions will remain in effect and these Terms and Conditions will be modified to give effect to the eliminated provision to the maximum extent possible.
- **15.** Laws. The Promotion shall be governed by and interpreted in accordance with the laws of Malaysia. The Promotion is void where prohibited or restricted by law and is subject to all applicable laws.
